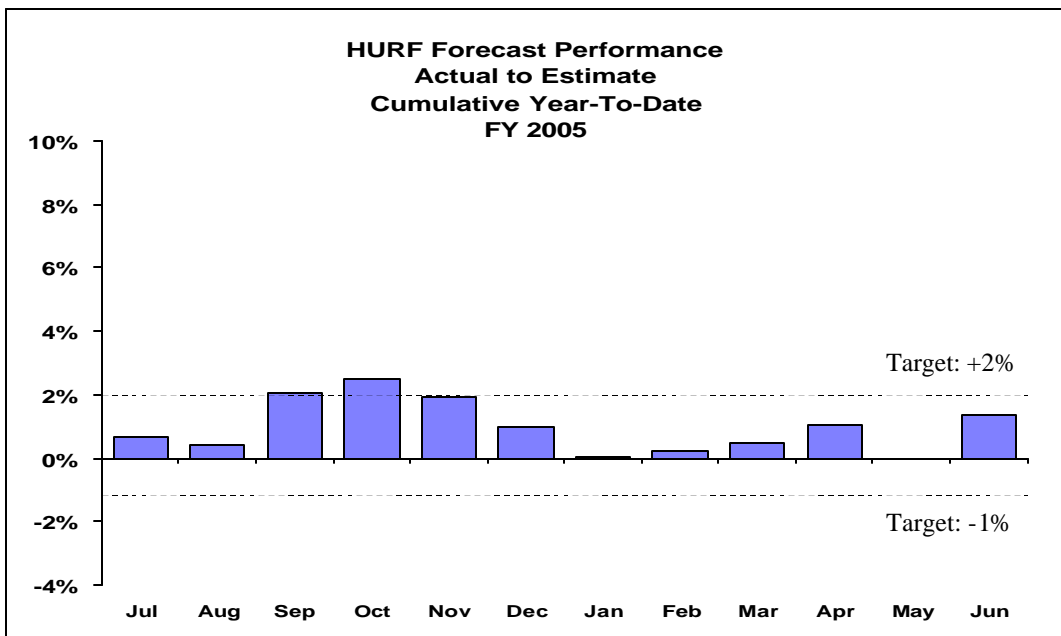

Summary:

FY 2005 HURF collections totaled \$1,245.5 million, an increase of 5.6 percent over FY 2004 and 1.4 percent above the estimate. HURF revenues in June totaled \$120.7 million, an increase of 22.3 percent over June 2004 and 16.6 percent above the estimate. This represents the largest single month of HURF revenues ever collected, but this was mainly attributable to timing in the commercial registration and **Vehicle License Tax (VLT)** revenues. For the year, all major revenue categories posted year-over-year gains in FY 2005.

Highlights:

- Even with the all-time high fuel prices, consumers and the trucking industry showed no slow down in fuel consumption during FY 2005 with the **Gas Tax** and **Use Fuel Tax** revenue categories posting year-over-year growth of 3.8 and 8.6 percent, respectively.
- Although the **Vehicle License Tax** revenue category ended the year 1.8 percent below the estimate, by adding back the \$7.4 million paid to the state general fund for the MVD registration enforcement program, the FY 2005 VLT collections would have been \$335.6 million or 0.4 percent above the estimate.
