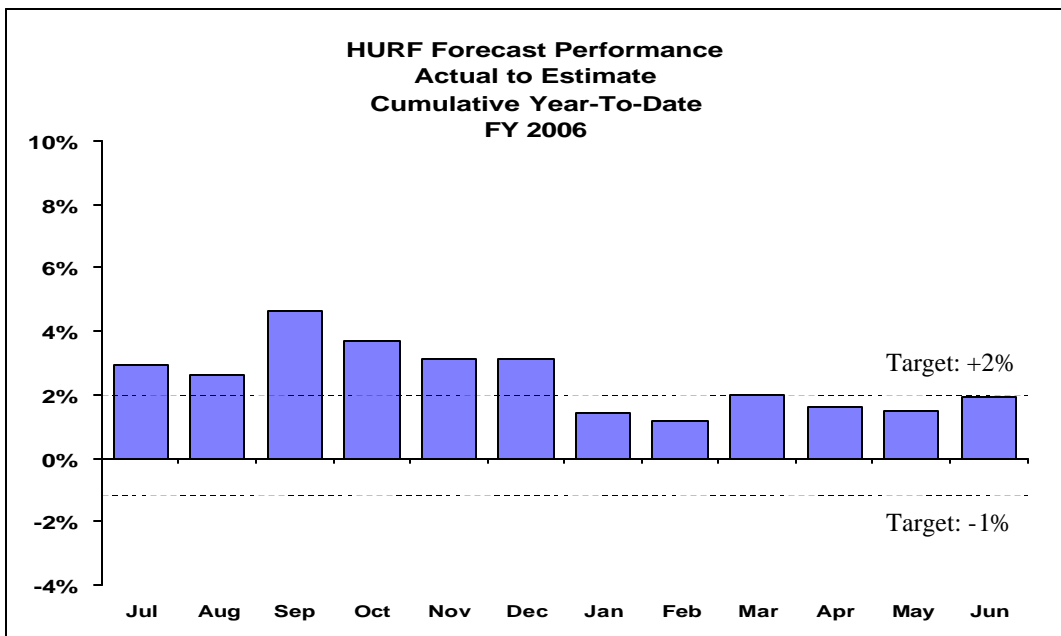

Summary:

FY 2006 HURF revenues amounted to \$1,331.6 million, an increase of 6.9 percent over FY 2005 and 1.9 percent above the estimate. June HURF collections totaled \$118.6 million, a decrease of 1.8 percent from June 2005, but 6.5 percent above the estimate. June 2005 revenues included a portion of the May 2005 commercial registration fees from IRP. All major revenue categories posted year-over-year gains with the weakest growth in the **Gas Tax** revenue category. Higher gas prices caused consumers to somewhat curtail their driving habits over the past year. According to AAA Arizona, the statewide average price of a gallon of gas was \$2.89 on June 29, 2006 compared to \$2.29 at the same time last year.

Highlights:

- The **Vehicle License Tax (VLT)** revenue category produced the largest year-over-year gain with a 13.9 percent over FY 2005. The main contributor to the **VLT** growth in FY 2006 was the renewal of an additional 370,000 used vehicles over FY 2005.
- The **Use Fuel Tax** revenue category posted a healthy 9.8 percent increase over FY 2005. The trucking industry continued to show strength even with the higher fuel prices.
