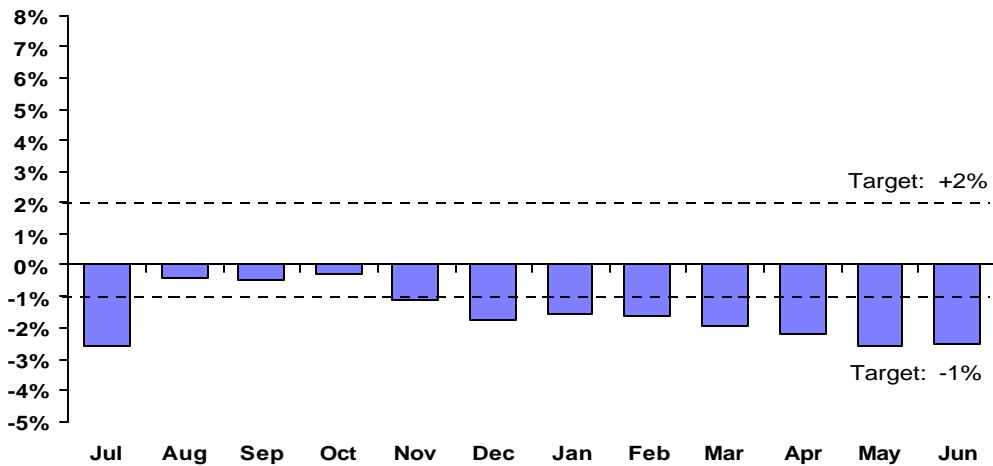

Summary:

FY 2003 RARF collections totaled \$268.7 million, an increase of 0.4 percent above the same time period last year, but 2.5 percent below the forecast. For the month of June, RARF collections totaled \$22.8 million, an increase of 3.3 percent above June 2002. When compared to the estimate, RARF collections were 1.3 percent below the estimate. The 0.4 percent growth in RARF collections during FY 2003 represents the slowest growth rate recorded since the inception of the tax in FY 1986. Weighing on the slow growth was the continued weak economy at the state and national levels as well as the limited job growth in Maricopa County.

Highlights:

- **Retail Sales** revenue category rebounded somewhat in FY 2003 with a 1.9 percent year-over-year growth rate. The FY 2002 growth rate was a negative 0.2 percent.
- **Restaurant & Bar** and **Rental of Real Property** revenue categories provided year-over-year growth rates of 4.1 and 5.0 percent, respectively in FY 2003. Consumers continued to dine-out and the hospitality industry experienced some improvement since the tragic events in September 2001.
