As of January 1, 2006, only 66.7% of the revenues collected in the County under the 2004 Excise Tax Authorization are transferred to the Maricopa County Regional Area Road Fund.
- (b) The figures shown in this column represent 66.7% of total excise tax collections within the County for fiscal years 2000 through 2009.

- (1) Includes retail sales of tangible personal property, excluding food sales.
- (2) Includes prime contracting and dealership of manufactured buildings, and operating as an owner-builder.
- (3) Includes producing and furnishing or furnishing to consumers of electricity, natural or artificial gas and water.
