- VLT distribution is as followed: 44.99 percent to HURF, 24.59 percent to county general fund, 24.59 percent to cities and towns, and 5.83 percent to counties for highway purposes. Additional VLT monies are distributed to cities, towns and counties collected from alternative fuel, rental and publicly owned emergency vehicles.
- Net of Yavapai cities and towns' repayment of \$14,820.11 to the Yavapai County treasurer for overpayment of VLT.
