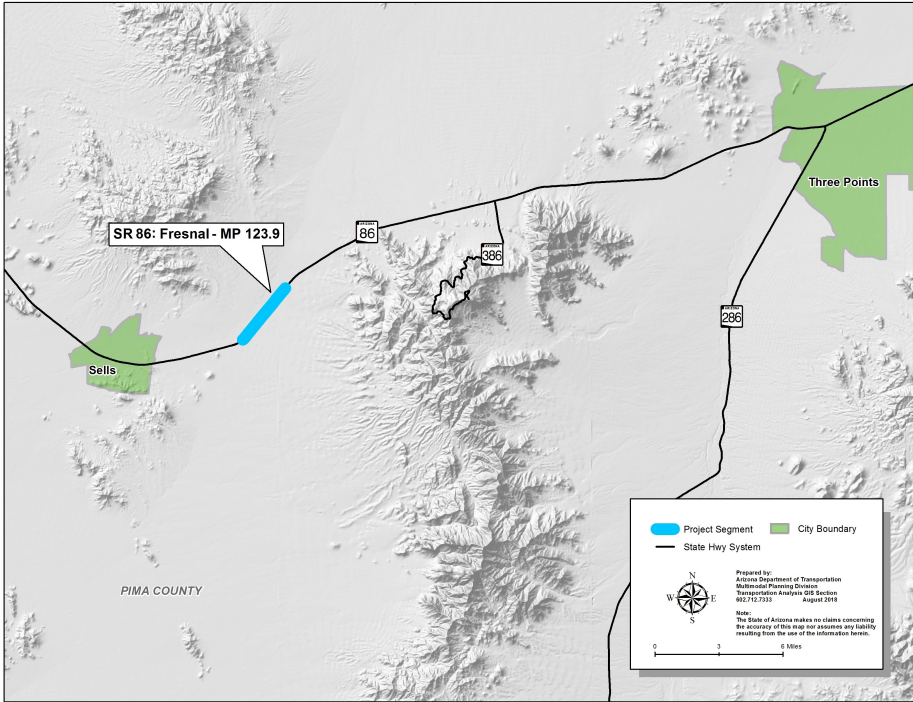

Increase Budget

26. JUSTIFICATION OF REQUEST

The Department's construction estimate of \$13.25 Million considered current unit prices that have been observed in similar projects in the area – Tohono O'odham Nation. The programmed amount of \$10.0 Million (the amount was originally shown in FY2016-2020 program for FY18 Construction, which was later deferred to FY19 Construction), is close to the consultant's 2014/2015 construction estimate. The consultant's March 2018 estimate although is also higher than the programmed amount, had unit prices of several items unchanged from its previous estimates. Some of the items that the unit prices needed to be updated are, Roadway Excavation, Aggregate Base, Asphaltic Concrete, Structural Concrete Mobilization, and Traffic Control related items.

The project is programmed under PAG RTP, including PAG 2.6pct funds.

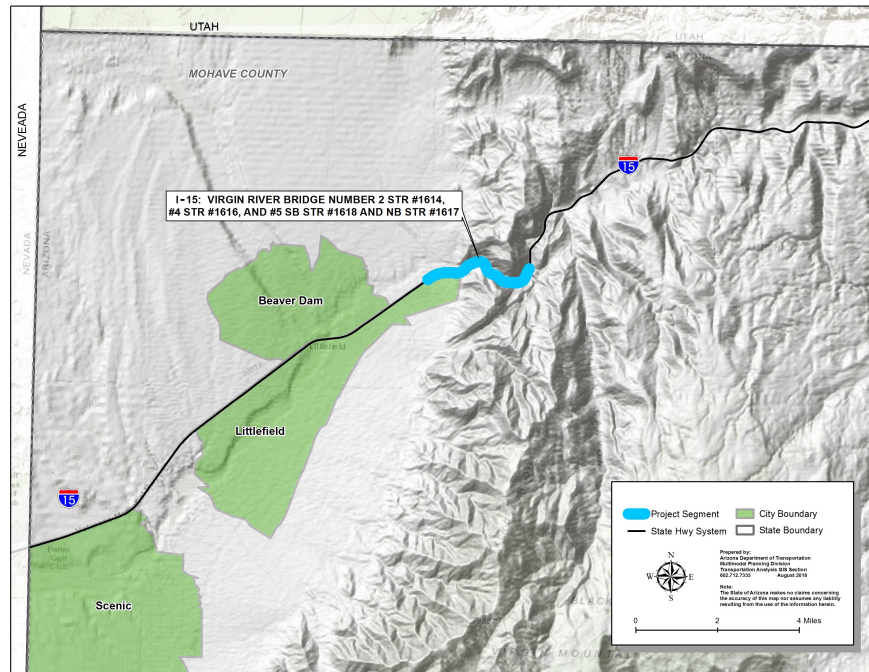

26. JUSTIFICATION OF REQUEST

During final design the design team included some items based on review comments during development. Silica fume concrete and methacrylate sealant treatment to all three bridges was included to reduce future maintenance needs in this remote location. These 3 bridges are also exposed to significant amounts of de-icing materials from vehicles leaving the adjacent mountainous areas of Utah. The guardrail was upgraded to the MASH standards. In addition a containment system is necessary to protect the canyon below Bridge #4 during deck removal. Construction engineering was increased to 25pct due to the remote location and is consistent with the CE costs ADOT experienced with recent improvements to VRB#1. ICAP is included in the request.

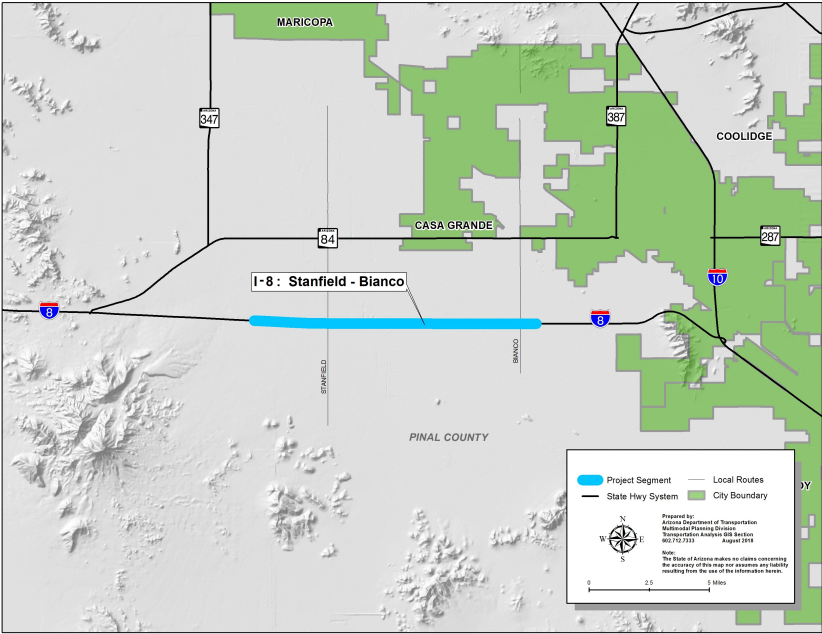

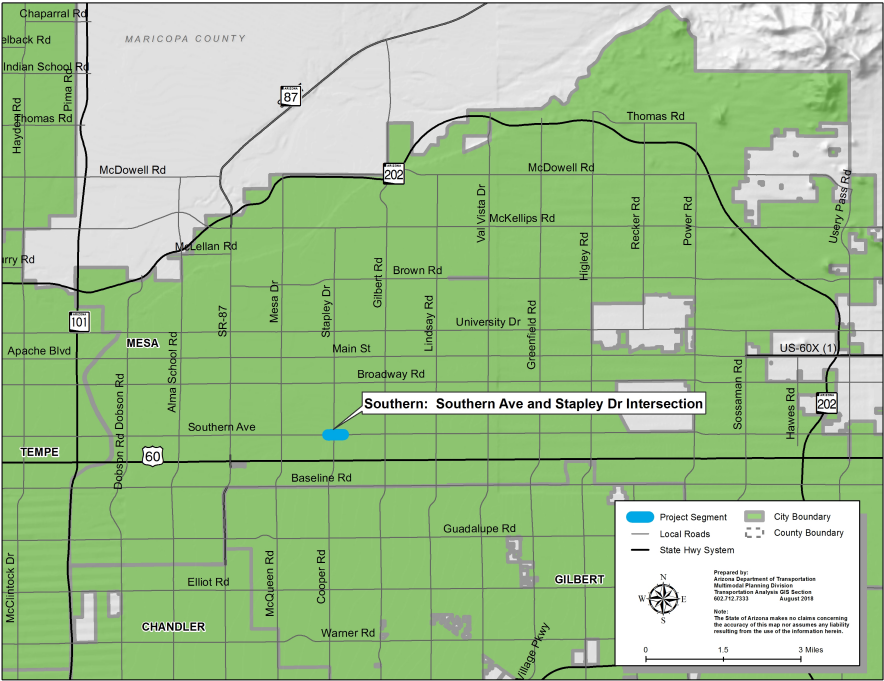

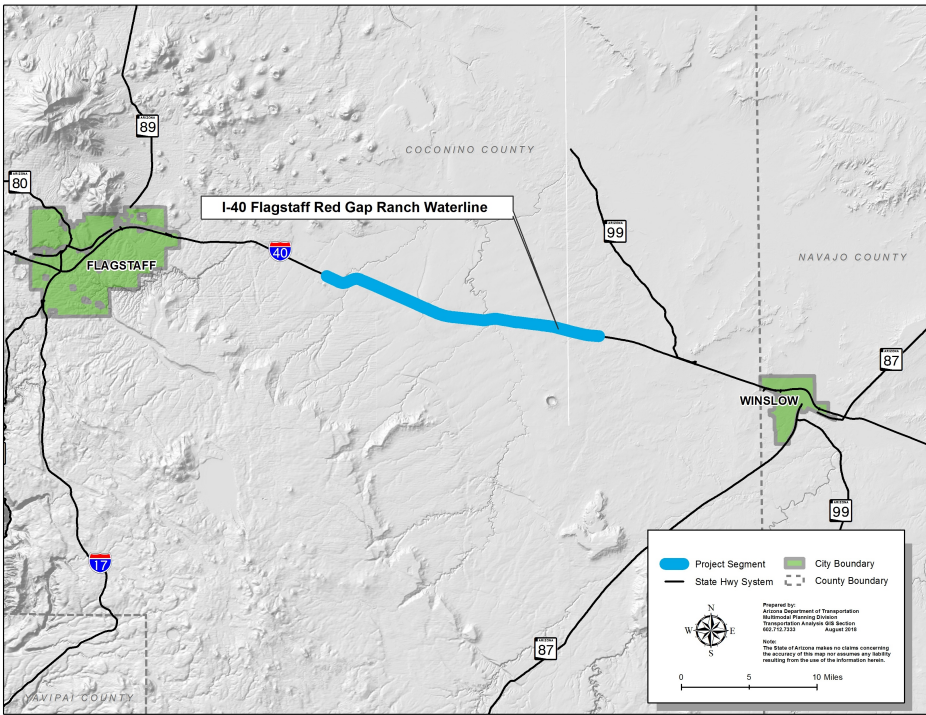
