MARY E. PETERS

Mary E. Peters served as U.S. Secretary of Transportation from 2006 – 2009. She oversaw all US aviation, surface and maritime policy and programs and negotiated transportation



I-11 Update: Build Corridor Alternatives and the No Build Alternative

The previous update (What is a Tier 1 Environmental Impact Statement) discussed the importance of identifying alternatives that meet the Purpose and Need of the project. The identification and analysis of alternatives are key to the process required under the National Environmental Policy Act (or NEPA). In addition

to the proposed Build Corridor Alternatives, all NEPA studies must include a No Build Alternative. The No Build Alternative represents the "do nothing" option or status quo, and is used as a baseline comparison and a viable option. So, what does that mean and how does it relate to the process, which is illustrated below?



What do these terms mean?

Build Corridor Alternatives

A Build Corridor Alternative is an area of land where an I-11 high-capacity transportation facility would be constructed to connect Nogales to US 93 north of Wickenburg. The Build Alternative may include construction of a new corridor, modification of existing corridors, or a combination of both. Modifications to an existing corridor could include a variety of improvements, such as adding travel lanes, adding interchanges or changing the access (e.g., upgrading a highway to a freeway by discontinuing access to and from driveways and side streets).

Since this is a Tier 1 EIS, decisions will not be made regarding specific roadway features or improvements. Rather, each Build Corridor Alternative is a 2,000-foot-wide area within which the I-11 facility could be built. (A facility would approximately 400 feet and would be specifically determined through Tier 2 studies.) The outcome of the Tier 1 EIS will be to select a Build Corridor Alternative to advance to subsequent studies, or to select the No

Build Alternative. Specific project activities and improvements needed to build a facility would be further evaluated once funding is identified in a future, more detailed and more specific NEPA environmental document.

No Build Alternative

The No Build Alternative means the proposed action — the implementation of the I-11 corridor - would not take place. For the I-11 Tier 1 EIS, it is the alternative in which no improvements related to the I-11 corridor would occur and the transportation system would remain "as is," with the exception of improvements currently planned and funded in the State Transportation Improvement Program. The No Build Alternative is used as a baseline comparison, or a benchmark, to compare against the Build Corridor Alternatives. It is used to understand the condition of the Study Area in the future with no proposed action, and also to understand how a Build Corridor Alternative could influence the Study Area — for better or worse. Depending on the outcome of the I-11 Tier 1 EIS analysis, the No Build Alternative could be the most viable or acceptable solution and recommendation.

How do the alternatives relate to the Tier 1 EIS process?

The Tier 1 EIS will assess the Build Corridor Alternatives and the No Build Alternative to consider a wide range of potential impacts. For example, the Build Corridor Alternatives and the No Build Alternative will be studied in the Tier 1 EIS to characterize how they compare in meeting the transportation purposes of the project, such as improving travel times, and what potential environmental effects could occur with implementation of each of the Build Corridor Alternatives.

The following graphic shows an example of a simple comparison of alternatives. Note: This graphic is being used only for illustrative purposes and is not based on actual evaluation criteria or

data. The graphic illustrates an existing interstate facility, three Build Corridor Alternatives, which include a combination of new corridors and their co-location with an existing facility, and a No Build Alternative. Generic evaluation measures show how potential environmental impacts may differ among alternatives and the types of considerations to expect in the Tier 1 EIS process.

Did you know?

U.S. Department of Labor (DOL) enforces the Fair Labor Standards Act (FLSA). To help employers learn about FLSA requirements, DOL has posted a new series of short COMPLIANCE VIDEOS. These brief, plain-language explanations of FLSA requirements strip away the "legalese" and provide employers the basic information they need to understand their obligations and to comply with the law. Visit the DOL website.

For example, view: <u>Hour Worked – Do I have to pay for that time?</u> Learn what counts as work time, and some common errors employers make in keeping track and paying for all the hours their employees work.

ADOT Bid openings after January 1st, 2017 will require prime contractors to submit DBE affidavits within 5 calendar days from bid opening. This is two days less than the current requirement. For example, if bid opens on Friday, the DBE Affidavits will be due to BECO, from the prime contractor, by Wednesday before 4:00 PM. Therefore, this is reducing the time DBEs and prime contractors have to prepare, sign and submit the DBE Affidavits to BECO. DBEs are urged to consider this new time restriction when working with prime contractors to complete and sign the DBE Affidavits in order for them to be submitted to BECO by the 5th calendar day from bid opening.
