## ADOT/ Pascua Yaqui Tribe LRTP Update Consultation Meeting

1. This meeting was held in response to Arizona Department of Transportation (ADOT) correspondence sent out to all tribes in Arizona with notification of project start-up and the opportunity for state-tribal consultation on the update to the Arizona Long Range Transportation Plan. Mr. Ian Geitner of the Pascua Yaqui Tribe Finance and Operations Department requested a consultation meeting at the ADOT Administrative Complex in Phoenix, Arizona.
2. Pascua Yaqui Tribe representatives were provided an overview of the AZ LRTP update project including the update process, stakeholder and public involvement input activities, a review of "Transportation in Arizona", potential plan goals, and next steps. The meeting also included a discussion on transportation issues and needs from the perspective of the Pascua Yaqui Tribe.
3. The Tribal representatives expressed a concern over the complexity of working with local governments in the Pima Association of Governments (PAG) Region. They also stated that they are interested in coordinating the programming and implementation of local projects with ADOT and representatives from the Southcentral District.
4. Jerry James expressed the department's commitment to work with the Pascua Yaqui Tribe to address key transportation system and operations related issues and concerns.
5. The Tribal representatives also stated concerns in defining and ultimately completing necessary steps and action items to arrive at point of implementation for individual transportation system improvements.
6. Charla Glendening stated that ADOT Multimodal Planning Division is committed to partnering with the Tribe to address planning and programming related topics.
7. Don Sneed stated that a new outreach project is under development within the department to assist tribal governments with identifying and accomplishing program development and project delivery. The project is entitled "Integrating Statewide & Tribal Transportation Planning Workshop" and involves conducting a series of workshops by ADOT in partnership with the Tribes in Arizona. The workshop curriculum is under final development at ADOT and workshops will be scheduled and conducted starting mid-2016. Don will remain in communication with Ian and Terry to confirm the Pascua Yaqui Tribe's interest in participating in a workshop later this year tailored to the local transportation related issues facing the Tribe.
8. Dan Marum offered to provide information to Ian on a Maricopa Association of Governments (MAG) checklist for "Designing Transit Accessible Communities".
