PROJECT OVERVIEW

In 2012, the Arizona Department of Transportation and the Federal Highway Administration began working on a study to enhance traffic flow at the I-19 and Ruby Road traffic interchange and along the I-19 EFR from Ruby Road to Rio Rico Drive. The study has included collaboration with community representatives and jurisdictions, including Rio Rico, Santa Cruz County and the City of Nogales.

The purpose of the study is to improve traffic flow and meet current and future traffic needs in this area. The study evaluated existing and projected peak-hour traffic operations and developed alternatives for potential capacity and operational improvements to accommodate forecasted growth through the year 2040.

AN ACTIVE AND GROWING CORRIDOR

The Rio Rico community, which was established in 1969 and has grown from 1,400 residents in 1990 to the current estimate of 20,000, is part of this study area.

- The I-19 east frontage road provides sole access to a warehouse district that is used by commercial trucks transporting goods along U.S.-Mexico trade routes.
- The east frontage road features two-way traffic (north- and southbound) from Ruby Road to Kipper Street and one-way traffic (northbound only) from Kipper Street to Rio Rico Drive (0.8 mile segment).
- Based on the current traffic configuration, all traffic entering the warehouse district must use the Ruby Road traffic interchange, while traffic exiting the warehouse district may use either the Ruby Road or Rio Rico Drive traffic interchange.
- There are also residential traffic and school buses in the area, which travel between the east and west sides of I-19.

Proposed Improvement Alternatives

The following are overviews of the alternatives under consideration to move forward. More details on these alternatives, and those that have been eliminated from further study, are available on the project website azdot.gov/l19ruby, or at the public meeting.

LEGEND LEGEND Alternative A

Alternative A:

Two-way frontage road extension to Rio Rico Drive

A two-way frontage road the entire length between Ruby Rd. and Rio Rico Dr. would allow ingress to the business park from both adjacent I-19 traffic interchanges (TI), thereby reducing backtracking. However, the Ruby Rd TI intersections are not improved.



Alternative B:

One-Way EFR South of Ruby Road, New Access Road

This alternative would convert the east frontage road south of Ruby Road to one-way northbound and combine it with the northbound I-19 exit ramp.



Ruby Rd LEGEND Alternative C

Alternative B1:

One-Way EFR South of Ruby Road, Southbound Access via

This is a sub-alternative of Alternative B. The land in the southeast quadrant of the I-19/Ruby Road TI is privately owned and may be developed as a truck stop; therefore, it may not be feasible to acquire part of the parcel for the access road included in Alternative B. Alternative B1 would not provide direct southbound access in the southeast quadrant of the Ruby TI; rather, southbound traffic south of Ruby Road would need to travel south on I-19 or the west frontage road to access homes and businesses south of Ruby Road and east of I-19.

on I-19 or the west frontage road to access homes a businesses south of Ruby Road and east of I-19. Alternative C: Roundabout Interchange This alternative would reconstruct the I-19/Ruby

Road TI as a roundabout interchange.



Alternative D:

Diverging Diamond Interchange (DDI)

This alternative would reconstruct the I-19/Ruby Road TI to a DDI. With a DDI interchange, crossroad traffic crosses to the opposite side of the roadway within the limits of the interchange to allow free right and left turns to and from the I-19 ramps.
