HDR Engineering (HDR) was requested to perform an environmental hazardous materials evaluation for the purpose of obtaining easements and completing work at the proposed traffic interchange (TI) of State Route (SR) 202L (i.e. South Mountain Freeway) and 32nd Street in Phoenix, Arizona. Initially, ROW acquisition for the South Mountain Freeway project identified larger sized parcels for which a full comprehensive Phase I analysis was an appropriate level of environmental review. As design progressed, subsequent ROW needs became much smaller, and new ROW or easements were often located adjacent to larger parcels for which Phase I Environmental Site Assessments had been previously conducted and approved. Phase I assessments were conducted for the Project Area in November 2012, and were updated in an addendum in June 2014. No concerns related to hazardous materials were identified in either assessment for the Project Area.

Based upon the availability of a previous Phase I assessment from a parcel located in the immediate vicinity (which revealed no environmental concerns), the Arizona Department of Transportation (ADOT) has approved a streamlined memo, since no land acquisition will occur, in lieu of a full Phase I analysis. This memo documents a review of Arizona Department of Environmental Quality (ADEQ) environmental databases (<http://gisweb.azdeq.gov/arcgis/emaps/>), an environmental database search performed by EDR, and a site reconnaissance.

The area included in this additional analysis was the approximately 0.2 miles of 32nd Street, from the South Mountain Freeway north to East Liberty Lane, referenced herein as the Project Area. The Project Area includes the area between the residential fencing, including: the 32<sup>nd</sup> Street roadway pavement, a drainage channel located on the west side of 32<sup>nd</sup> Street, and a sidewalk with decorative landscaping located along and east of 32<sup>nd</sup> Street.

### Site Reconnaissance

The additional work area is located between the SMF and East Liberty Lane. The Project Area is shown on the next page. The red, yellow, and brown boxes indicate a drainage easement, temporary construction easement, and Project Area, respectively.

On Friday, September 7, 2018 HDR conducted a site reconnaissance of the Project Area. The Project Area was a residential area, with a high school located to the northwest. A grass and gravel lined channel was present on the west side of 32nd Street. A pad-mounted transformer was located on the southeast corner of East Liberty Lane and 32nd Street. The transformer was in good condition, with no signs of staining. No environmental concerns were located within the Project Area. Photos from the site reconnaissance can be found in **Attachment A**.

### EDR Database Review

EDR was contracted by HDR to complete a database search for federal, state, and tribal environmental records for the Project Area. This database search was done in order to update environmental records that were reviewed during the previous Phase I effort. HDR

provided EDR with the Project Area boundaries and search parameters (a one-quarter-mile radius), as a buffer zone. A computerized environmental information database search was completed by EDR on September 13, 2018.

The EDR database search resulted in 5 total listings located within the ¼ mile buffer zone. An underground storage tank (UST) was listed approximately 1/4 mile north of the Project Area. The UST was removed in September 1985, and based on its proximity to the Project Area and date of removal, this listing is not of concern. The other 4 listings reported by EDR were not of concern to the Project Area, also based on distance. The full EDR report can be found in **Attachment B**.

#### **ADEQ eMaps Review**

The ADEQ eMaps geographical information system (GIS) search was conducted on Friday, September 14, 2017. The search was done for Brownfield sites, large quantity generators, treatment, storage and disposal sites, landfills, Superfund sites, and USTs. The review of the ADEQ eMaps did not return any sites that would be of concern to the Project Area.


#### **Limitations**

HDR has performed this PISA-equivalent review of the Project Area in lieu of completing a full Phase I, according to the methodology approved by ADOT. Prior Phase I investigations in the immediate vicinity found no sites or issues of concern, and this assessment verified that finding for the new work area. It is important to note that this investigation does not, and was not intended to, fulfill the requirements of an ASTM-conforming Phase I Environmental Site Assessment.





The EDR Proprietary Manufactured Gas Plant Database includes records of coal gas plants (manufactured gas plants) compiled by EDR's researchers. Manufactured gas sites were used in the United States from the 1800's to 1950's to produce a gas that could be distributed and used as fuel. These plants used whale oil, rosin, coal, or a mixture of coal, oil, and water that also produced a significant amount of waste.
