

ADOT'S NONDISCRIMINATION NOTICE TO THE PUBLIC

Project Schedule


Constructed in phases from Feb 2023 to late 2025





Project Overview


- Widen four miles of I-10 from three lanes to four lanes in each direction
- Merge lanes to create two-lane entrance and exit ramps
- Construct additional lane in each direction near the Ina Road Interchange

Project Overview

- (cont) Reconstruct Orange Grove Road Interchange
- Reconstruct Sunset Road Interchange to bring Sunset Road over I-10
- Reconstruct I-10 bridges over the Cañada del Oro Wash and Rillito River
- Construct new bridges at Sunset Road over the Union Pacific Railroad and Rillito River
- Retaining walls, drainage, lighting, landscaping and other misc. improvements





Sunset Road Project Overview

- Pima County project to extend Sunset Road to River Road
- The project is part of the 2006 voter-approved RTA 20 year multimodal plan. The project scope consists of roadway and bridge improvements necessary to extend Sunset Road to River Road.





I-10 Mainline & Orange Grove Rd Incentives

- Contractor must have all I-10 mainline travel lanes open, and Orange Grove ramps open within 645 calendar days (currently November 2024).
- Contract has a daily incentive of \$36,500 to have these elements open to the public sooner, with a maximum incentive of 67 calendar days. The maximum incentive dollar value is \$2,445,500.
- If the contractor completes the project 67 days early (maximum incentive), it would move the opening of Orange Grove and I-10 mainline to as early as September 2024.
- This timeline can change and is dependent on other factors.



Anticipated Traffic Impacts

- ADOT will maintain access to all businesses.
- Alternate routes will be required during most of the project.
- I-10 will remain open to three lanes of traffic during peak travel times.
- I-10 overnight lane restrictions from 8 PM to 5 AM during weeknights.
- WB I-10 shifted to the westbound frontage road.
- EB I-10 will be shifted to the existing I-10 WB lanes and eastbound frontage road.
- Ruthrauff Road/El Camino del Cerro interchanges, and the Ina Road interchanges will remain open during the project.



Anticipated Traffic Impacts (cont)

- Sunset Road and all I-10 ramps at Sunset Road will be closed between Silverbell Road and I-10 for the duration of the project.
- The westbound frontage road will be closed near Sunset Road. It will be converted to a twoway road between the closure point and the Ruthrauff Road on-ramp to westbound I-10 (with no direct access back to Ruthrauff Road).
- A temporary exit ramp on I-10 EB will provide access to businesses located on the eastbound frontage road between Sunset and Ruthrauff roads.

Anticipated Traffic Impacts (cont)


- EB on/off ramps and WB on-ramp at Orange Grove will be closed until late 2024.
- Access to CalPortland will be maintained during construction via temporary entrance and exit ramps.
- WB-off-ramp at Orange Grove Road will be open, with the exception of a 50 day closure window expected in Summer/Fall 2024.
- River Road will be reduced to a single lane in each direction while the connection to Sunset Road is constructed.





Anticipated Traffic Impacts (cont)

- The eastbound frontage road will be closed near Walker Road. It will be converted to a two-way road between the closure point and the Ina Road on-ramp to eastbound I-10 (with no direct access back to Ina Road).
- Access to and from Walker Road will be maintained.


