**#15 SR 87, SR 260 Junction to Clints Well/Lake Mary Rd**

**#22 US 93, Pacerita - Date Creek Ranch**

**#23 US 93, I-40 - Windmill Ranch Rd**

**#24 US 93, Sohi Estates**

**#25 US 93, Legend Ranch Rd - Mineral Park Rd**

**There are a revised total of 23 projects going to the State Transportation Board totaling \$50,473,600. The other projects will be programmed in FY 2024 for an estimated \$40,000,000. The new list of projects will be presented at a future PPAC Meeting.**
