



# SR 89A PAVEMENT PRESERVATION COTTONWOOD

## OVERVIEW

The Arizona Department of Transportation has initiated a pavement preservation project along State Route 89A in Cottonwood (mileposts 353-356).

## PROJECT ELEMENTS

- ▶ Remove the existing top layer of asphalt and replace it with new pavement.
- ▶ Install new sidewalks, driveways, sidewalk ramps and handrails that are in compliance with current Americans with Disabilities Act (ADA) standards.
- ▶ Remove and install new pedestrian push buttons on traffic signal posts that are in compliance with current ADA standards.
- ▶ Install new concrete curb and gutter.

## PROJECT SCHEDULE

Construction is expected to begin this summer and be completed in early 2024.

## WHAT TO EXPECT

While the project is underway, motorists will encounter daytime lane restrictions and should plan for possible delays.

- ▶ Work will occur from 5:30 a.m. to 5:30 p.m. Mondays through Fridays. Hours subject to change as daylight hours change.
- ▶ A minimum of one lane in each direction will remain open on SR 89A during construction. No work is anticipated to occur on weekends or holidays.
