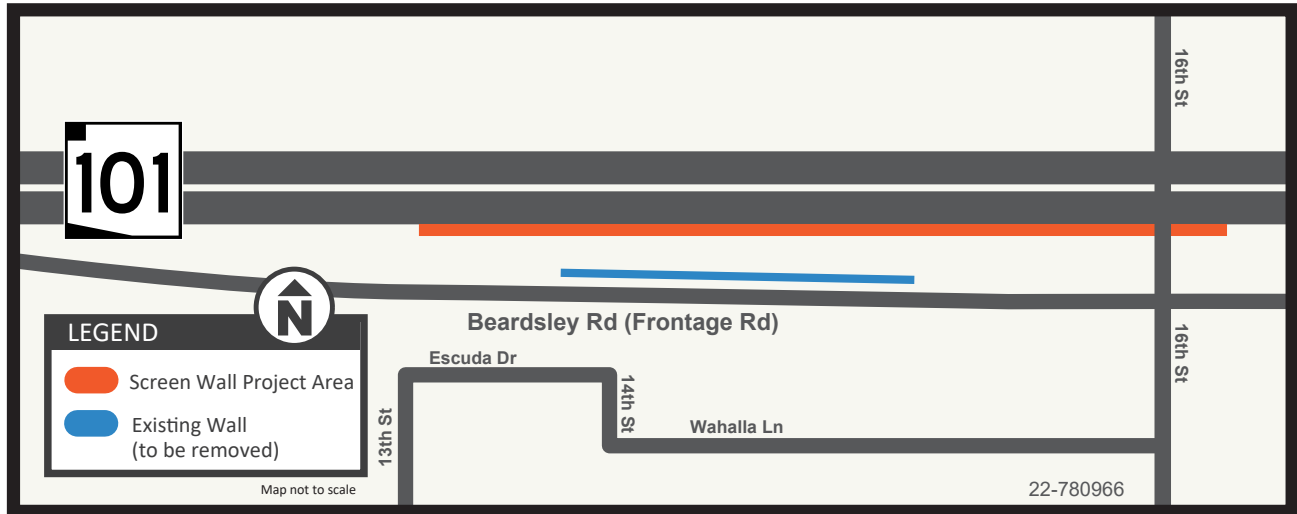




Loop 101/16th Street Screen Wall construction to begin July 24

CONSTRUCTION NOTICE

The Arizona Department of Transportation advises residents to be aware that work to build screen walls along a section of eastbound Loop 101 near 16th Street is scheduled to begin Monday, July 24.



WHAT TO EXPECT DURING CONSTRUCTION

- ▶ Work will primarily occur during daylight hours on weekdays. Some night and weekend work will be required to pour concrete and perform other work on the walls.
- ▶ Work will require lane restrictions on the eastbound Loop 101 frontage road (Beardsley Road).
- ▶ A section of the frontage road will need to be completely closed for a brief period to allow crews to set traffic control barriers.
- ▶ 16th Street under the Loop 101 bridge will need to be completely closed on some weekends for work on the lightweight screen wall on the bridge.
- ▶ ADOT will provide advance notice about all lane restrictions and closures.
- ▶ Crews will have a staging and parking area in Buffalo Ridge Park on the southeast corner of the eastbound Loop 101 frontage road (Beardsley Road) and 16th Street.

The project is expected to be completed in approximately nine months.

Note: This information is subject to change due to weather or other unforeseen conditions.
