		that allows ADOT to partner with private entities to develop and
		implement projects. As an example, ADOT used the P3 contracting process for the construction and maintenance of the South
		Mountain Freeway. The P3 law has a requirement that if a fare, toll
		or other fee will be charged in association with the infrastructure
		project that a hearing must be held to get public comments. And
		there will be a fee to charge electric vehicles at the NEVI funded
		stations.

	Thor	received two exceptions on the Interstates: one on I-8 and the other on I-40. Each station must have at least four 150 kW Direct Current Fast Chargers with CCS connectors. We aren't going to require the NACS (aka Tesla) connectors in this procurement for the Interstates because a national standard for this connector has not yet been established and EV charger manufacturers haven't yet incorporated it in their equipment. However, ADOT's request for proposal will allow prospective EV station developers to propose the inclusion of additional connector types if they have the ability to do so. Our NEVI program is being implemented using a phased approach. We are updating our plan annually and adding new alternative fuel corridors with each update.
15	ADOT's EV Plan Phased Approach Thor	So, in 2022 we submitted our initial EV deployment plan covering the Interstate freeways and this is the plan we are implementing in this procurement. We recently submitted a 2023 plan update with seven new alternative fuel corridors, shown in red on this map, and this plan was approved by the Federal Highway Administration at the end of September.
16	ADOT's EV Plan Phased Approach Thor	This public-private partnership is a little different from the ones that ADOT normally does. Normally, ADOT takes ownership of the infrastructure developed using the P3 process. This will not be the case for the Electric Vehicle stations that will be constructed under this P3. No State funding will be used to construct the charging stations. 80% of the funding will be federal and the remaining 20% will be provided by the private sector developer. The private sector owners will set the charging fee and the State won't receive any of the proceeds from that fee.
17	2022 EV Plan Implementation Thor	We plan to issue a request for proposals for EV stations along the interstates in January. The advertisement will last for 90 days, and we expect to make selections in the second quarter of 2024. Station build out is expected to take at least a year. We plan to advertise for developers to build stations along the alternative fuel corridors identified in the 2023 plan update next fall.
