

# John Wayne Parkway (SR 347) Improvements — Smith-Enke Road (SR 238) To Maricopa City Limits **CONSTRUCTION NOTICE**

## EXPECT ONGOING LANE, TURN **RESTRICTIONS ON JOHN WAYNE** PARKWAY THROUGH MID-2024

The Arizona Department of Transportation (ADOT) advises drivers to plan for ongoing lane and turn restrictions on SR 347/John Wayne Parkway, between the northern Maricopa limits and Smith Enke Road (SR 238) for a project to widen and repave the roadway. Drivers should be prepared to slow down and use caution around construction personnel and equipment.

### WHAT TO EXPECT

- Work will primarily occur Mondays through Fridays, during daytime hours, with possible evening and weekend work.
- Traffic will be restricted to one lane on north- and southbound SR 347 at times.
- Left and right turn lane closures also will be needed.
  - The left turn lane from northbound SR 347 to westbound Cobblestone Drive will be closed from late October to late 2023. Northbound drivers may use the southern entrance to Cobblestone Drive just north of Smith Enke Road for alternate access.
- Periodic closures of east-and westbound Cobblestone Farms Drive/Lakeview Drive will be needed for paving across the intersection.
- Construction is expected to take approximately nine months.
- Access to businesses and neighborhoods will be maintained.
- \*Schedules are subject to change based on weather and other unforeseen factors.

### **ABOUT THE PROJECT**

In cooperation with the city of Maricopa, ADOT is initiating a project to widen northbound John Wayne Parkway (SR 347) for approximately 1.3 miles from Smith-Enke Road (SR 238) to just north of the city limits. This project will help relieve traffic congestion and improve travel times by widening northbound SR 347 and improving the Lakeview Drive intersection.

Other key elements of the project include:

- Adding a northbound acceleration lane for traffic moving westbound to northbound at the SR 347/Lakeview Drive intersection.
- Reconstructing the existing Lakeview Drive paved median and widening the intersection.
- Repaving within the project limits.
- Adding curb and gutter along the east side of SR 347 from north of SR 238 to Lakeview Drive.
