#### On-The-Job-Training with Goals: 9230003

- □ The contractor shall provide On-The-Job training (OJT) aimed at moving minorities, women, and disadvantaged trainees into journeymen status in various types of construction trades or job
- □ It is the intent that training be provided in construction classifications/crafts rather than for office support positions
- $\Box$  A minimum amount of OJT hours is established on this project
- $\Box$  Each trainee is expected to achieve a minimum of 600 hours of training
- $\square$  Prime Contractor may utilize approved subcontractors on the project to meet OJT goal on the project
- □ Prime Contractor retains primary responsibility for meeting the training requirements on the project
- □ All OJT Compliance Submittals will be completed in ADOT's DBE and OJT Online Reporting System (DOORS)

#### OJT Training Programs: 923-1.04

□ Copy of contractor's Approved Training Program must be on file with BECO prior to commencing training on project

#### OJT Commitment Schedule: 923-3.01

- □ Identifies Prime Contractor's commitment to meeting the project's OJT Goal
- $\hfill\square$  Must be submitted no later than the Preconstruction Conference
- $\square$  Supplemental OJT Schedule can be submitted for approval throughout the life of the project
- □ If OJT commitment is less than the assessed OJT goal on the project contractor must submit Good Faith Efforts explaining the efforts made to meet the project's OJT goal

#### OJT Enrollment: 923-3.01 (B) and Monthly Training Reports: 923-6 (A)

- □ Trainee must be enrolled in the project's OJT Module in DOORS to count towards the OJT Goal
- □ Monthly Training Report(s) must be submitted by the 15<sup>th</sup> of the month for the previous month
- Only hours achieved the week of enrollment into DOORS (and beyond) are eligible to be reported on the Monthly Training Reports to count for credit towards the OJT Goal
- □ Contractor is eligible for \$3/Hour reimbursement on all approved OJT hours in DOORS

#### Banking-Carryover Hours: 923-3.03

- □ OJT hours achieved by a trainee in excess of the minimum required amount of hours on a project may be transferred to count towards a future project's OJT Goal\*
- □ Banked-Carryover hours will only be credited when the same trainee who completed the excess hours is transferred to a future project
- □ Prime Contractor is not eligible for additional reimbursement on banked/carryover hours

#### Compliance Determination: 923-6(D)

 $\Box$  BECO will determine the Prime Contractor's compliance with the OJT requirements throughout the project  $\Box$ Good Faith Efforts can be made throughout the life of the project if Prime Contractor is not meeting the assessed OJT goal or commitment
