## SR 187: SR 387 to SR 87 Improvement Project

### OVERVIEW

The Arizona Department of Transportation has initiated a project to improve State Route 187 located in Pinal County beginning late summer 2024 and is projected to take eight months to complete. These improvements will include pavement preservation, shoulder widening, and new turn lanes. Gila River Indian Community members will see ADOT and construction staff performing survey work in the area prior to construction starting.

### PROJECT ELEMENTS

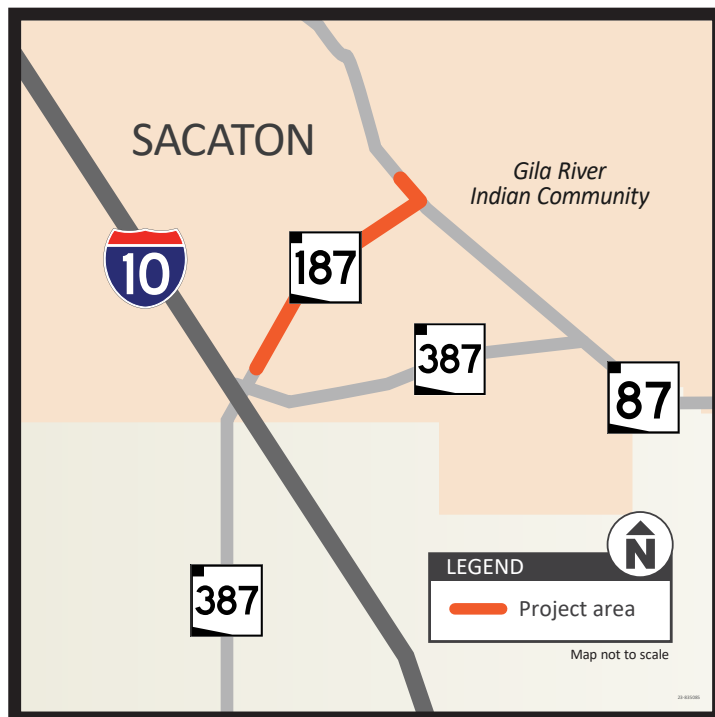
- ▶ Adding a new right-hand turn lane on SR 187 approaching SR 87
- ▶ Adding a new right-hand turn lane on SR 87 approaching SR 187
- ▶ Adding new left-turn lane on SR 187 approaching Casa Grande Road
- ▶ Widening the roadway to accommodate 8-ft shoulders on both sides
- ▶ Removing and replacing five inches of asphalt
