# **Resolution or Empty Promise?**

## New Year, New Focus: 5 Resolutions for a Healthier, Wealthier Business

Are you a resolution keeper or an empty-promise expert? Or perhaps you have done away with setting annual declarations and prefer a minimalist (and undercover) approach to continuous improvement.

According to a Forbes Health survey conducted on Oct. 23, 2023, fitness is this year's most common New Year's resolution. Here are some more details, and the bold accents indicate our interest:

- 62% feel pressured to set a New Year's resolution.
- Women (64%) feel slightly more pressured to set a resolution than men (60%).
- Overall, 48% of people say improving fitness is a top priority in 2024, while 36% cite improved mental health as a top resolution (respondents could select more than one).
- 55% say physical and mental health are of equal importance.
- More people cite improved fitness as a top resolution (48%) compared to improved finances (38%), improved mental health (36%), weight loss (34%) and improved diet (32%).
- Women (36%) and men (36%) equally cite improved mental health as a top resolution for 2024. However, women are more likely to focus on fitness (52%) in 2024 than men (42%).



# **Camp Verde OKs Road Project Agreement with ADOT**

The Campe Verde Town Council has approved a joint project agreement with the Arizona Department of Transportation (ADOT) for the Finnie Flat Road and Montezuma Castle Highway Corridor Improvement Planning and Designing Project.

The vote was 7-0.


The town received a Strengthening Mobility and Revolutionizing Transportation (SMART) grant totaling \$896,500 from the U.S. Department of Transportation for the project. According to the <u>meeting agenda</u>, the covered work "consists of design services for the beautification, widening and resurfacing of Finnie Flat Road from Highway 260 to Main Street, Main Street from Finnie Flat Road to Turner Street, and Montezuma Castle Highway from Main Street to the Black Bridge. The project includes realignment of the tri-intersection of Finnie Flat Road, Main Street and Montezuma Castle Highway, approximately 2 miles. The local agency has received funding through AZ SMART fund for the design of the project. The project cost, shown in Exhibit A, is estimated at \$896,500, which includes AZ SMART funds. The state will administer the design. The construction phase of the project will be addressed in a separate agreement for the design of Finnie Flat improvements from Highway 260 to



the tri-intersection and from the Medical Center Hospital to the Black Bridge site near the public library."

According to the presentation to the council during the Dec. 20 meeting, the agreement allows ADOT to administer the SMART grant portion of the process, manage contractor selection and solicitations, and ensure compliance with the grant provisions.

ADOT will handle the process until a contractor is selected then town officials will work with the contractor to help with the design.



# Flagstaff Gets \$9.6 Million Grant for Street Conversion

The U.S. Department of Transportation has awarded the city of Flagstaff \$9.6 million to convert a roughly one-mile section of Butler Avenue into a modern thoroughfare with enhanced bicycle and pedestrian accessibility.

The Butler Avenue Complete Streets Conversion project will install bike lanes separated from vehicle traffic, implement three protected intersections, upgrade existing pedestrian crossings, add one new crossing and reduce motor vehicle speeds in the city's southside neighborhood. Along Butler Avenue between Milton and Sawmill roads is Flagstaff's highest bicycle-crash corridor. Officials expect to reduce the number of incidents and improve safety with the renovations.

Flagstaff has already received \$58 million in funding for transportation and infrastructure projects under the Infrastructure Investment and Jobs Act, according to a statement from Mayor Becky Daggett.

MetroPlan of greater Flagstaff contributed to the city's grant writing and application process.

Work is planned to begin in the spring and finish by summer 2026. (Source)



# Arizona Construction Employment Up by 3,300 Jobs in November 2023

Arizona's seasonally adjusted unemployment rate increased to 4.3% in November 2023, up from 4.2% for the month of October 2023, according to the latest <u>report</u> published by the Arizona Office of Economic Opportunity.

The national unemployment rate decreased to 3.7%, down from 3.9% in October 2023. In November 2022, Arizona had a seasonally adjusted rate of 4.0%, while the national rate was 3.6%.

The Construction sector added 3,300 jobs around the state November 2023.

Arizona had a gain of 35,900 jobs in nonfarm employment in November. "Prior to the pandemic (2010-2019), NSA nonfarm employment gained 28,800 jobs on average in November," the report states.

The private sector gained 35,400 jobs over the month, led by Trade, Transportation and Utilities adding 16,600 jobs and Professional & Business Services adding 9,100 jobs. Government gained 500 jobs.

Ten of the 11 sectors tracked reported gains in November. The only sector to lose jobs was Other Services, which dropped 100. Year-overyear, eight of the 11 sectors reported gains, including Construction's addition of 6,900 jobs.

#### **Construction Employment**


Statewide construction employment totals 205,400 jobs. In November 2022, the sector reported 198,500.

The Arizona Construction sector features three major segments: Buildings, Heavy, and Specialty Trades. There are currently 45,800 jobs in Buildings, which is up 400 from October 2023 and up 3,300 from November 2022. Heavy Construction added 600 jobs for the month, for a total of 24,000, and added 1,200 over the year. Specialty Trades added 2,300 jobs over the month for a total of 135,600, and the segment gained 2,400 year-over-year. Construction jobs in the Phoenix Metro Area (Phoenix-Mesa-Scottsdale) added 2,500 jobs over the month for a total of 164,000. The November 2022 number was 156,700. Metro Tucson added 200 construction jobs over the month at 20,400, which is an increase of 600 year-over-year.

Yuma, Flagstaff, Prescott, Lake Havasu City-Kingman and Sierra Vista-Douglas combine Mining and Construction jobs in reporting their job sector totals. Yuma, Prescott, Lake Havasu City-Kingman were unchanged over the month, with 4,200, 7,200 and 4,300 construction jobs reported, respectively. Flagstaff added 100 jobs for a total of 3,100, as did Sierra Vista-Douglas at 2,100.
