



Interstate 40 Mohave County: Holy Moses Wash-Walnut Creek PAVEMENT PROJECT

OVERVIEW

The Arizona Department of Transportation is initiating a project this spring to replace the top-riding surface along a 14-mile section of Interstate 40 between Holy Moses Wash and Walnut Creek southwest of Kingman (mileposts 33-47).

PROJECT ELEMENTS

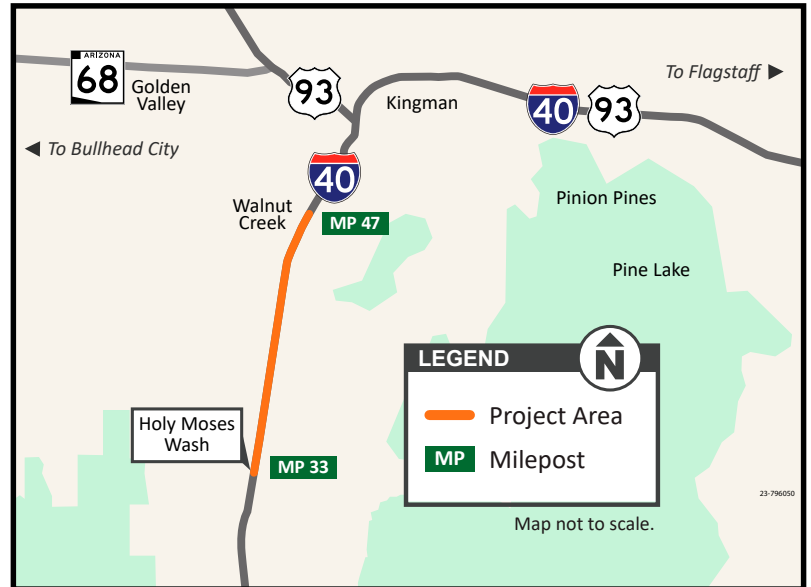
- ▶ Milling and paving the roadway.
- ▶ Replacing and installing new embankment curb, drainage features and guardrail.
- ▶ Repairing bridge decks and performing barrier work on seven bridges.
- ▶ Re-stripping the newly paved roadway and other related work.

PROJECT SCHEDULE

Work to repair the seven bridge structures started in fall 2023. Paving operations are anticipated to begin in early May 2024. The project is scheduled to be completed in winter 2025.

WHAT TO EXPECT

- ▶ Lane restrictions will be in place during both day- and nighttime hours.
- ▶ One lane will remain open in each direction at all times.
- ▶ Motorists should be prepared for delays up to 15 minutes.
- ▶ The speed limit will be reduced in the work zones.
- ▶ Access to business and other driveways will be maintained during construction. However, there will be brief restrictions when work takes place directly in front of driveways.
- ▶ Construction-related noise.
