Land Sale Advances Future State Park

Trust for Public Land, in partnership with Arizona State Parks and Trails (ASPT), Yavapai County, Nature Conservancy and the town of Chino Valley, has announced the protection of 734 acres that is now owned by ASPT.

A new state park will not only connect folks to the outdoors but will protect Sullivan Lake at the start of the Verde River, enable the extension of the Peavine National Recreation Trail from Prescott to the river and preserve the history of great importance to Arizona.

Arizona State Parks and Trails plans to develop its newest park on the newly acquired land. Following a comprehensive planning process, ASPT will be able to offer additional outdoor recreation opportunities in north-central Arizona.

The property contains the same abandoned rail bed that will enable the extension of the Peavine National Recreation Trail, one of the few "rail to trail projects" in the state, from its start at Watson Lake and Granite Dells in nearby Prescott to the start of the Verde River, a distance of 25 miles. It will result in a trail available for a variety of non-motorized recreational uses including mountain biking, horseback riding and hiking.

Through a community-based master planning process coordinated by landscape architect Peter Bourgois hired by Trust for Public Land, more than 30 organizations from public agencies to colleges to nonprofit organizations, and the public at large described the importance of conserving this special place.

Land Sale Advances Future State Park (Cont'd)

Protection of this property will result in nearly all of the first 25 miles of the Verde River being in public ownership (from the property's Sullivan Lake to Arizona Game and Fish Department's Upper Verde Wildlife Management Area and land owned by Arizona State Land Department to the Prescott National Forest). This upper stretch of the Verde River is actively being proposed for Wild and Scenic River status, a congressional designation that would maintain the river's ecosystems and protect clean water supplies for future generations.

The land also includes a significant part of its namesake, Del Rio Springs.

A substantial portion of the funds to acquire the land, \$6 million, was provided by the Arizona legislature through a capital appropriation in the current year's state budget to create a new state park at the headwaters of the Verde River.

Yavapai County contributed \$1.5 million toward the purchase of the land with funds available to it through the federal American Rescue Plan Act of 2021.

Given the importance of protecting the Verde River, The Nature Conservancy provided a major grant that was critical to the success of this project. The Nina Mason Pulliam Charitable Trust also provided a grant to Trust for Public Land that was instrumental in project costs.

The sellers of the property, Bob O'Rear and Jim Brown of Del Rio Springs Loan Partners LLC, also made a major contribution to the project by selling the land at a significant discount from its appraised value. They were represented by Land Advisors Organization.

DO THIS

- Keep relevant projects relevant. List projects that will be meaningful to the reader, even if it is a shorter list.
- Add enough information to the project listing to show what the person did on the project, such as role, areas of responsibility, specific contributions.
- Provide all types of credentials that build up the authority of the team member. Military veterans often have a list of courses that indicates they have been given special project management, leadership, or special training. These elements may also connect the reader to your team member on a different level.
- Include relevant experience that the individual had from a prior employer – and be sure to indicate that it was from another firm. Your team members bring valuable insights and lessons learned from their long employment history.
- Be creative. Be visually appealing. Be branded. Be outstanding. Answer "So what?" and show why this person is someone that is the perfect fit for this project.

DON'T DO THAT

- Do not show their entire list of projects that cross a wide spectrum of types just to impress the reader.
- Do not put the same project description that will be shown in the Project Experience section. That is wasting real estate.
- Do not omit special certifications and courses, even if they seem irrelevant to the requirements.
- Do not "accidentally" forget to mention the person worked on a project while with another firm and give the impression that your firm has the project experience. Clients know which companies did which projects, and this is misrepresenting facts.
- Do not be dull or ho-hum.

Construction Input Prices Up 1.4% in February

Construction input prices increased 1.4% in February compared to the previous month, according to an Associated Builders and Contractors (ABC) analysis of the U.S. Bureau of Labor Statistics' Producer Price Index data. Nonresidential construction input prices increased 1.3% for the month.

Overall construction input prices are 1.5% higher than a year ago, while nonresidential construction input prices are 1.8% higher. Prices increased in two of the three energy subcategories last month. Crude petroleum input prices were up 7.5%, while unprocessed energy materials were up 3.6%. Natural gas prices declined 7.2% in February.

"For the last several weeks, inflation data have been coming in hotter than anticipated," said ABC Chief Economist Anirban Basu. "This was also true for the February construction input price data, which indicated that upward price pressures are reemerging after a period of calm. Monthly inflation was apparent in several categories, including brick/tile, gypsum and steel mill products. With supply chains around the world rattled by military conflicts and other phenomena and workers' wages far higher than they once were, there is reason to believe that inflation will remain stubbornly high for months to come.

"For contractors, today's release is bad news for at least two reasons," said Basu. "First, higher input prices implicate lower demand for construction services all else equal. With project financing costs already elevated, project owners are less likely to move forward with construction work given already high and rising input costs.

"Second, recent inflation data render it more likely that interest rates will remain higher for longer. For weeks, the conventional wisdom has been that the Federal Reserve was poised to reduce interest rates. Today's inflation data, along with other releases, suggest that hopes for rapidly declining rates were somewhat premature." (Source)
