

Rancho Santa Fe Parkway Traffic Interchange

OVERVIEW

The Arizona Department of Transportation, in partnership with the city of Kingman, will begin construction in December on the new Interstate 40 Rancho Santa Fe Parkway traffic interchange in east Kingman at milepost 57. The project will improve travel by providing a direct connection to the future Rancho Santa Fe Parkway.

PROJECT ELEMENTS

Work includes:

- ▶ Constructing two new bridges on I-40 at the new Rancho Sante Fe Parkway interchange.
- ▶ Widening the existing bridges over Rattlesnake Wash.
- Installing new sidewalks and curb/gutter.
- Construct/install pipe culverts, concrete box culverts and storm drain.
- Installing new traffic signals and lighting.
- Installing new fencing, guardrail, signage and pavement markings.
- Other related work.

After construction on the new interchange is completed, the city of Kingman - as a separate project - will construct the new Rancho Santa Fe Parkway north of I-40 that will connect to the Kingman Airport.

WHAT TO EXPECT

- ▶ Day- and nighttime construction activities Mondays through Thursdays (only daytime on Fridays).
- ▶ Parkway interchange ramp alignment when crews construct the new bridges over Rancho Santa Fe Parkway.
- ▶ Two lanes will remain open in each direction on I-40.
- Drivers should be prepared for delays up to 20 minutes during portions of the project.
- ▶ The speed limit will be reduced in the work zone.
- ▶ Construction-related noise and lights (for nighttime work).
- Motorists should use caution and watch for construction workers and equipment when driving through the work zone.

Construction is scheduled to last approximately one-and-a-half years.
