Centennial Boulevard and Pinal Avenue (SR 387) Intersection Improvements

PROJECT FACT SHEET

OVERVIEW

The Arizona Department of Transportation in partnership with the city of Casa Grande will begin a project in fall 2025 to install a traffic signal at the intersection of Centennial Boulevard and Pinal Avenue (State Route 387). Additional improvements will feature: curb ramps for pedestrian accessibility, a new right-turn lane and other related items.



PROJECT ELEMENTS

- ▶ Installing traffic signals, pedestrian push buttons, and lighting on all four corners of the intersection
- ▶ Constructing new sidewalk ramps
- ▶ Constructing a right-turn lane from Pinal Avenue (SR 387) to Centennial Boulevard
- ▶ Installing signage
- ▶ Restriping the intersection
- ▶ Other miscellaneous improvements

PROJECT SCHEDULE

- ▶ The project is scheduled to begin construction in fall 2025 and is expected to be completed early 2026. Schedules are subject to change due to weather and other unforeseen situations.

WHAT TO EXPECT

- ▶ Flaggers and temporary portable traffic devices will direct traffic through the project area during construction.
- ▶ One lane of travel will be maintained during construction.
- ▶ Construction is tentatively scheduled from 6 a.m. to 6 p.m. Monday through Friday.
- ▶ ADOT will provide advance notice of restrictions and closures to email subscribers and on the project website.
