2024 State Management Plan - Notice for Public Comment

The Federal Transit Administration (FTA) provides financial assistance to states through a number of programs to develop new transit systems and improve, maintain, and operate existing systems. FTA requires that each state adopt policies and procedures to be used in administering FTA Title 49 USC Sections 5310, 5311, and 5339 grant programs and produce a plan describing the state's policies and procedures for the state-managed portion of these programs. Arizona DOT has also included all FTA funding managed by ADOT MPD Transit in the plan.

This State Management Plan for Federal Transit Administration Public Transportation Programs describes Arizona DOTs administrative procedures for these FTA programs. The Arizona DOT MPD Transit Group is providing notice to our stakeholders of the issuance of the draft plan and seeks comment on the plan.

The purpose of this document is to inform FTA, subrecipients, and the public as to Arizona DOTs role in the administration of FTA funds. The FTA programs covered by this plan under 49 USC are:

- § 5303/5304 Metropolitan and Statewide Planning Programs
- § 5307 Urbanized Area Formula Program
- § 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program
- § 5311 Rural Area Formula Program
- § 5311(b)(3) Rural Technical Assistance Program (RTAP)
- § 5339 Bus and Bus Facilities Program

This plan provides information on the management of FTA programs, with emphasis on Sections 5310, 5311, and 5339. The Department adheres to all FTA requirements that are set out in the respective program guidance Circulars published by the FTA or exceeds FTA requirements where appropriate.
