

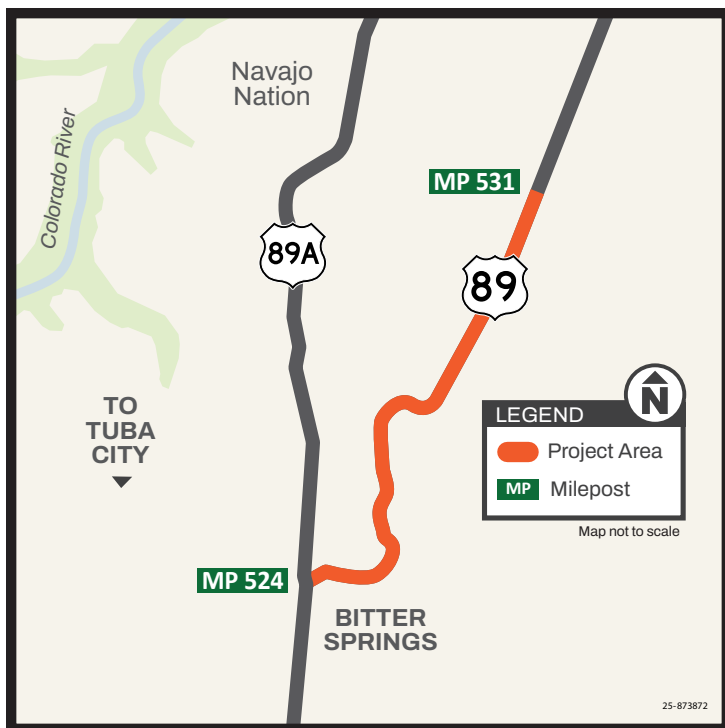


US 89 Bitter Springs Pavement Preservation

PROJECT FACT SHEET

OVERVIEW

The Arizona Department of Transportation, in cooperation with the Navajo Nation, has initiated a pavement preservation project along US 89 from Bitter Springs north for approximately seven miles (mileposts 524-531).



PROJECT ELEMENTS

- ▶ Remove and replace the top layer of asphalt.
- ▶ Install pavement striping.
- ▶ Install ground-in rumble strips.

PROJECT SCHEDULE

The project is expected to be under construction in June 2025 and anticipated for completion by fall 2025.

WHAT TO EXPECT

Daytime lane restrictions will be in place from 6 a.m. to 5 p.m. Mondays through Thursdays and from 6 a.m. to noon on Fridays, as needed. Flaggers and a pilot car will be onsite to guide drivers through the work zone.

ADOT advises drivers to plan for possible delays while the work is underway.
