



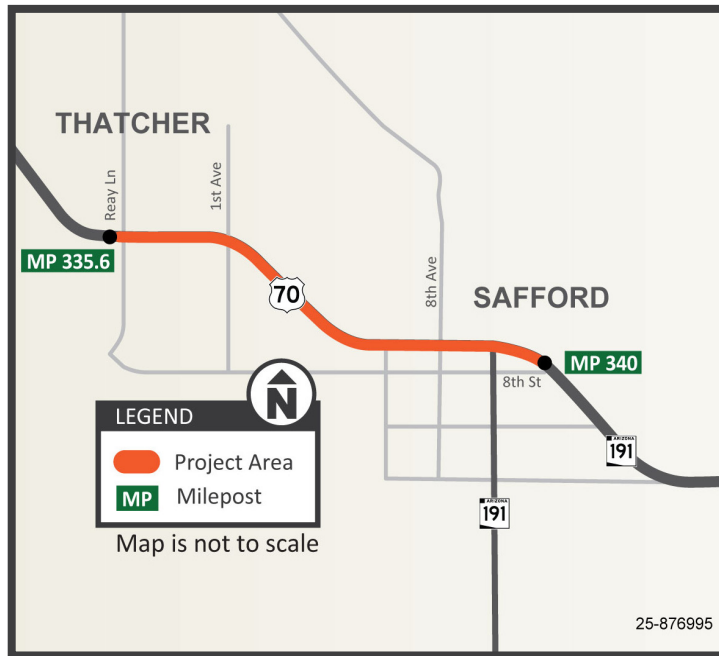
US 70: Reay Lane to 8th Street

PAVEMENT REHABILITATION PROJECT

OVERVIEW

The Arizona Department of Transportation is conducting a pavement rehabilitation project on east- and westbound US 70 between Reay Lane (milepost 335.6) and 8th Street (milepost 340) in Thatcher and Safford.

This project will improve the roadway pavement condition, update pedestrian facilities and repair drainage elements.



PROJECT ELEMENTS

- ▶ Replace existing asphalt with new asphalt
- ▶ Improve existing driveways and curb access ramps
- ▶ Repair box culvert at milepost 337
- ▶ Apply fog seal coat
- ▶ Complete new pavement markings and replace signs

PROJECT SCHEDULE

Construction on this project began in early October 2025 and is expected to be completed by spring 2026.

Work hours will vary throughout the project. To receive advanced notice of construction hours, sign up for traffic alerts on the project website.

Schedules are subject to change because of weather and other unforeseen situations.

WHAT TO EXPECT

Pedestrians should anticipate intermittent curb access restrictions throughout the project area and motorists should anticipate the following restrictions:

- ▶ Intermittent daytime lane restrictions and speed reductions in the work zone for sidewalk, curb and other improvements
- ▶ Nighttime lane restrictions and speed reductions for milling and paving. During milling and paving operations:
 - Temporary closures to driveways and cross streets
 - Traffic signals turned off/inactive at intersections. Law enforcement officers will direct traffic

ADOT will provide information about restrictions and closures in advance to email subscribers. Drivers should expect delays and allow for extra time when traveling through the area.
