1. Relevant Experience

RHA has been providing facilitation and training services over the past 32 years. Our general experience includes:

Evaluation, Assessment and Process Improvement – RHA has been involved with many organizations and projects where evaluation, assessment and process improvement have been a key aspect. First and foremost, one of the benefits of hiring RHA is that we bring additional tools and techniques to ADOT to aid in these endeavors. We use our value management certification and experience, including leading process improvement studies as stated above. Additionally, RHA has other local experience working with the City of Phoenix with improving their internal Customer Satisfaction Process with their Rideshare Program and Project Delivery process.

Monitoring and Evaluation - Additionally, RHA has been providing evaluation and assessment for Partnering workshops since we first started working with ADOT, using the PEP program, as well as we have developed our own Team Maintenance on-line, web-based program. This was done to aid other states and local agencies to give them the tools that they do not have to help monitor and assess how teams are working together. We've also used these tools to aid teams in understanding how they are currently working together and help determine the best course of action. Additionally, RHA encourages **Executive groups** for larger projects.

ADOT Core Team - Renee Hoekstra served as a member of the Partnering Core Team for almost six years. This included attending and participating in quarterly meetings to help to develop and improve the Partnering processes adopted by ADOT and the AGC as well as developing governmental and stakeholder partnering approaches.

Everyday Counts Initiative 4 – Partnering and e-Construction – RHA had been involved with helping the FHWA to implement part of Initiative 4. We were hired by NDOT to develop and deliver a Partnering conference nationwide to engage various agencies and private sector individuals to discuss the status of Partnering, potential areas for growing and improving Partnering as well as develop a Partnering Toolbox of materials that would be available to all agencies. 2. Demonstrated Knowledge, Skills and Abilities

RHA has been providing formal facilitation and training for 32 years. Our experience and our facilitators possess the capability, experience, and expertise to provide a variety of facilitation and partnering services including, but not limited to:

Facilitation and Industry Practices – as has been demonstrated in our capabilities above, RHA has been engaged in the Partnering industry for transportation and related services almost since its inception in Arizona in 1991. Additionally, we have spent years working with various teams in building teams, developing relationships, working with testing instruments to build better teams with an understanding of how to work better together. Additionally, RHA has been on the cutting

edge of developing new and improved practices to continue to deliver exceptional workshops with high-functioning teams.

Prepare for Workshops and Customize Workshops - RHA believes that it is very important to have preliminary dialogues with the key representatives and partners prior to developing a workshop approach. We spend preparation time to gain insight into the past experience of each organization; learn specific details about the program, team, process, etc.; understand past working relationships of team members and the expectations for the workshop. RHA then develops a program and details a program outline that meets the customized needs of every workshop. Each team is different in what they may require. This is a key element in helping teams succeed.

Methods to Bring About Consensus – Each team is different, participants have their own distinct personalities and approaches, and these must be taken into account. Reaching consensus is about ensuring team members engage, voice their issues and concerns and, using various types of tools, determine the final approach that the team agrees to embrace. It's not about that they agree, but it is about their willingness to support goals and decisions.

Facilitation Techniques – RHA facilitators have been facilitating workshops of all types including Partnering, issue escalation meetings, facilitated dispute resolution workshops, value engineering, stakeholder integration, team building workshops, risk workshops, and many more. RHA also teaches facilitation skills to those individuals wishing to learn how to better run meetings and workshops.

Effective Issue Resolution and Conflict Management – As much as we'd like to say that team members should not take issues "personally," the truth is that this is their job and it is "personal." The skill is to help them see that the problem or issue at hand has nothing to do with them, it's about the project, program or process. We use various communication and resolution tools as well as teaching and integrating negotiation skills and tools to help the team members see the benefits and impacts to achieving success together. Depending on the issue, it is also sometimes important to educate team members about the potential impact of not resolving issues.

Steering Conversations – Items as listed above all are about steering conversations and bringing about a focus on the "project" and not on the "person." This requires expert facilitation skills and the ability of our facilitators to stay neutral, calm and help the teams stay focused on the issues at hand. It is very easy for teams to digress, and our understanding of design and construction allows us to understand when this has occurred and to keep the discussions on track.

Administering and Reviewing Progress Assessments – RHA has been helping teams to successfully maintain their teams throughout the length of a project or program. Team maintenance is a key factor in the overall success of teams. It provides an avenue for the team members to be able to provide a rating and then a subsequent discussion of how the team, overall, is performing on the goals and identified approaches that they identified would ensure a successful team. The ratings also provide an avenue for the Executive team to see how the team is performing and keep them up to date. All too often, if maintenance is not part of a team, specific behaviors, attitudes and processes begin to fail and if left unchecked, can have a very negative impact on the overall project. These include:

Monthly Evaluation – RHA has worked with ADOT and the PEP program for years, as well as offering their own on-line, web-based programs for teams without a formal process. We help to identify project champions to be the lead for the team and we work with them to review and evaluate the monthly evaluations to understand how to look for areas that may need a course correction or an opportunity for the champions to reward exceptional behaviors and attitudes.

Turn-around Workshops – When project teams need to refocus their efforts on effective issue resolution, conflict management and improving communication.

Maintenance Workshops – These short workshops help to keep teams and projects on track by allowing teams to discuss both the positive and negative aspects and focus on maintaining a strong team.

Facilitated Issue Resolution – Very specific facilitated sessions focusing on team issues and coming to resolution.

Keeping Team Members Engaged – The workshop itself is one thing and we pride ourselves on our continued efforts to keep the process fresh and new and to make sure that the actual workshops are focused on the project. We build teams throughout the workshop, engage the team members to take a strong role during the workshop as well as during the project. We are very careful to ensure that when we have repeat team members that we continue to provide new information about communication, problem solving, issue resolution and negotiation.

Encouraging Trust and a Safe Environment – Again, we have covered these aspects in other bullets; however, one of the things that we really focus on is the importance of Trust and our team’s ability to maintain open and honest lines of communication. We impress upon them the criticalness of Communication in building trust and especially the need to be able to speak freely, but what is important for the teams to understand is that they still must maintain a professional manner. We continue to promote the “Platinum Rule.”

Reflecting and Recording Vital Communication – One of the key elements of successful facilitation is our ability to realize what is important to record versus allowing the teams to just have more casual conversations that continue to help them build their relationships. The other element that is very important is our ability to maintain on-going conversations while still being able to record the vital information to be included in a final report for each team.

Meeting Coordination – RHA has been providing coordination for workshop venues for 32 years. Understanding that ADOT has specific rules related to procuring facilities is important and the amount of time it can take, so understanding the needs of the workshop is important. We are available to aid or take the lead in any of the workshop details.

Innovation and Creativity for Delivering Workshops – RHA has a vested interest in ensuring that Partnering succeeds and over the past 32 years, it has taken looking to new approaches, new tools and techniques, and new programs. As an example, RHA has developed a **Risk-based Partnering** approach to take Partnering to the next level. We also use the tools of risk management and value management to give us other tools to help teams reach understanding and consensus.

Staff Skills Training – RHA has been providing training for UDOT, Caltrans, NDOT and WSDOT over the past 18 years. This includes skill development; including communication, problem solving, decision-making, issue resolution and negotiation. This is to aid team members to improve their abilities to be effective team members.
