



# Interstate 40 and Fourth Street

## BRIDGE WIDENING PROJECT

### PROJECT OVERVIEW

The Arizona Department of Transportation and the Federal Highway Administration, in partnership with the city of Flagstaff, have initiated a project to widen the Fourth Street Bridge over Interstate 40. This project will provide additional capacity for vehicles, bicycles, and pedestrians on Fourth Street in Flagstaff.

### WHAT TO EXPECT

**Overall Restrictions:** Work will occur in three construction time windows with the primary traffic restrictions occurring between April 1 and Oct. 1.

Expect construction-related noise from around-the-clock jackhammering as crews begin excavation work beginning April 1.

- ▶ Fourth Street will be CLOSED around-the-clock in mid-July for 17 consecutive days. Emergency vehicle, bicycle and pedestrian access will remain open during the closure.
- ▶ Fourth Street will be narrowed to one lane during overnight hours with flaggers directing traffic through the work zone from April 1 to Oct. 1.
- ▶ Two weekend FULL CLOSURES of Fourth Street. Emergency vehicle, bicycle and pedestrian access will remain open during these closures. Dates to be determined.
- ▶ I-40 traffic will be detoured onto temporary crossovers through the work zone.

**Restrictions between March 1 and April 1:** Crews will work on pre-construction activities next to the roadway in preparation of the demolition and widening of the Fourth Street Bridge over I-40.

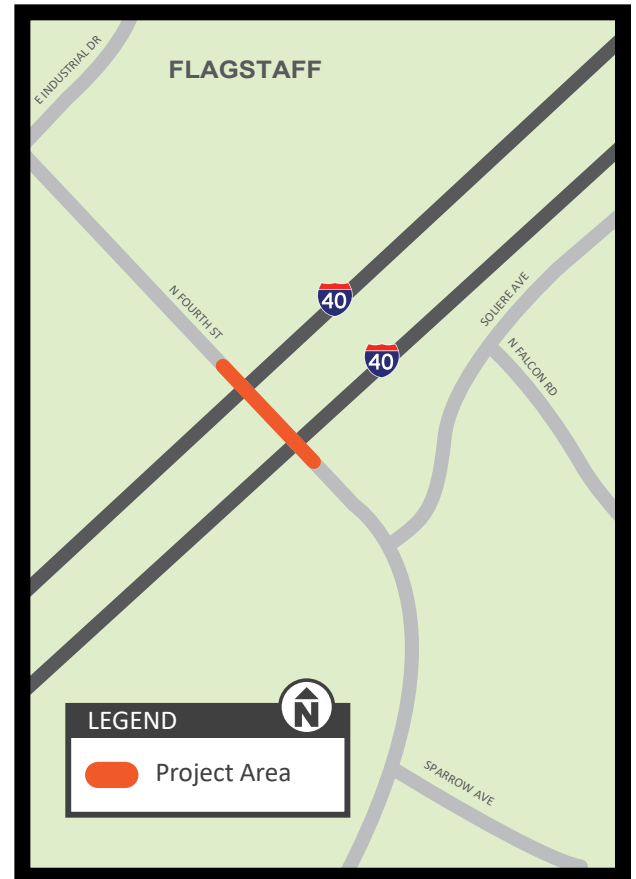
- ▶ Both directions of I-40 will have shoulder closures and lane restrictions with reduced speeds beginning late March.

**Restrictions between April 1 and Oct. 1:** The demolition and removal of the old bridge and construction of the new bridge will require numerous traffic restrictions.

- ▶ Single-lane closures in one direction at a time on I-40 during nights and weekends.
- ▶ Two weekend FULL CLOSURES of Fourth Street. Emergency vehicle, bicycle and pedestrian access will remain open during these closures. Dates to be determined.
- ▶ Fourth Street will be narrowed to one lane during overnight hours. Emergency vehicle, bicycle and pedestrian access will remain open through the construction zone. Flaggers will direct traffic through the work zone.
- ▶ A 17-day, around-the-clock FULL CLOSURE of Fourth Street will be required in mid-July. Emergency vehicle, bicycle and pedestrian access will remain open during this closure.

**Restrictions between Oct. 1 and 31:** Crews will perform final project work including pavement striping and landscape work. This will require lane closures while the work is being performed.

ADOT will provide advance notice of restrictions and closures.
