ADOT to host Small and Disadvantaged Business Enterprise Virtual Conference

PHOENIX – To continue assisting members of disadvantaged groups during the current public health situation, the Arizona Department of Transportation is hosting a virtual conference in December to help owners of small businesses become more competitive within the highway industry.

Registration is now open at https://adot. 6connex.com/event/ADOT/login for ADOT's Disadvantaged Business Enterprise (DBE) and Small Businesses Conference, scheduled for Dec. 8-9. The conference will include an orientation for new and prospective DBE firms, 15-minute speed appointments with agencies and prime contractors, and an opportunity to learn about ADOT programs designed to help build businesses.

The goal: help small businesses and those owned by members of socially and economically disadvantaged groups compete for transportation projects that receive federal funding.

With a theme of "Building for Success," workshops through a virtual platform, the conference will focus on people power, smart transportation and finding projects.

Although the conference is geared toward disadvantaged business enterprises and small businesses, it's open to all businesses, public agencies, vendors and community partners with an interest in highway related industry.

The virtual conference is one of several virtual gatherings ADOT has employed to engage members of the public during the current health situation and need for social distancing.

This summer. ADOT held a virtual public hearing on the future Interstate 40/US 93 traffic interchange in Kingman, allowing participants to listen and provide input on the project while others could listen to the meeting simultaneously on local radio stations. The attendance and public comment levels rivaled that of traditional, in-person public hearings.

ADOT has also used virtual technology to host construction academies, small business workshops, and the agency's Border Inspection Unit held online training to help truck drivers in Mexico better understand and prepare for inspections at the border.

How To Create Value That Keeps Clients Coming Back

Tips to help you avoid becoming a commodity

Most business owners find it challenging to identify what sets them apart from their competitors. They're in the trenches every day, and it's easy to stay focused on the challenges and tasks in front of them. Then, when they're in the midst of negotiating a contract, it seems like clients are just interested in the bottom line, aka your low cost proposal.

When the only thing clients use to compare services or products is price, you've become a commodity. And then it's a race to the bottom—lowest cost and barebone services.

When companies demonstrate value for their services, they have a better chance of long-term success and sustainable growth. Here's how.

First, here are some important definitions.

A **commodity** is a basic good used in commerce that is **interchangeable** with other commodities of the same type. (James Chen, Investopedia, 2/14/2020)

Value is the regard that something is held to deserve; the **importance**, worth, or usefulness of something. (Oxford Languages)

When a product or service is a commodity, price is the only discriminator. Below are some low-cost value-added tactics that your clients will love.

1.) Make your client's job easier.

Consider all the interactions you have with clients, and make them smoother, easier, and hassle-free. Do you return calls quickly, or do your clients have to call you several times to get an answer to a problem? Set a goal to respond to phone calls and emails within 24 hours (or quicker).

What about your invoicing process? Is it easy for you – AND your client? Ask your customers what their requirements are, and make sure your invoices are set up to help them, not just you.

If you're required to provide documentation for services, materials, etc., make sure your paperwork fits THEIR needs, not just "this is the way we always do it." While it's time-consuming to change paperwork processes for every client, your value will skyrocket because you're adapting to them, not forcing them to comply with you.

What's THEIR best communication method? Phone? Virtual? Email? Text? Be flexible and adaptable to their preferences, so they'll find it easier to work with you.

2.) Help your client win work.

Keep your ear to the ground and let them know if you hear of an upcoming project. Without risking confidentiality agreements or promoting unethical practices, help your customers identify opportunities, and they're likely to remember you when it comes time to submit proposals.

Refer your clients to other businesses contacts and friends. Be a "connector" in the business community. People like people who help them create success.

Provide testimonials—even when you're not asked to. Do you have a great working relationship with a customer? Write a note or send an email letting them know how great it was to work with them. And remind them that you're always available to serve as a reference. (And make sure you respond quickly to those reference calls and emails requesting your feedback!)

3.) Make your client a priority.

Check in to find out how your clients are doing.... even if they don't have a specific project for you right now. Let them know you're thinking about them, and create a strong human connection. People like to know that you're interested in them, not just looking for the next project.

Write thank you notes and emails. Drop by their offices with a box of donuts or goodies (respecting physical distancing and safety protocols, of course!) If you use social media, share your clients' posts and congratulate them on success. Show genuine gratitude, which is bound to increase your value as a vendor.

Do what you say you're going to do. Do your job well. It may seem like a no-brainer, but just doing what you'll say you do is not as common as you may think. Be reliable, responsible, and do a good job. Your clients and customers will love you for it.

Providing exceptional value doesn't always require charging a higher price. When companies make their client's job easier, help them be successful, and show that they care, the result is repeat clients who love working with you.

Provide value to show your worth, and don't give clients a reason to work with anyone else. When you help your customers be successful, your busines will grow!•

Interchange Improvements Planned On Loop 101 Between Princess Drive And Shea Boulevard In Scottsdale

Drivers can comment on planned new interchange designs through online survey

The Arizona Department of Transportation has partnered with the city of Scottsdale and the Maricopa Association of Governments on an upcoming project to widen the Loop 101 (Pima Freeway) between Princess Drive and Shea Boulevard by one general-purpose lane in each direction, as well as modify existing interchanges to improve traffic flow. Final design of this project is scheduled to begin next year and construction is planned to begin in late 2022 or early 2023.

The Design Concept Report (DCR) for this project is currently being updated to modify the proposed interchange designs to better accommodate increased traffic volumes in this area. The proposed revised concepts modify the interchange design at Frank Lloyd Wright Boulevard to a new diamond configuration and make minor modifications to the interchanges and crossstreets at Princess Drive, Raintree Drive and Shea Boulevard to improve turning movements.

Public Input Sought For I-10 Wild Horse Pass Corridor Improvement Options Between Phoenix And Casa Grande

Public encouraged to attend Nov. 18 public meeting and provide commentsonline survey

With a goal of reducing traffic congestion on Interstate 10 between Loop 202 (Santan Freeway) and State Route 387, the Arizona Department of Transportation, in cooperation with the Gila River Indian Community, the Bureau of Indian Affairs, the Federal Highway Administration and the Maricopa Association of Governments, is conducting a study to evaluate options for widening I-10 and modifying traffic interchanges and crossroads to improve traffic flow.

A live, call-in/online public meeting will be held Nov. 18 between 5:30 and 7 p.m. to provide details about the alternatives being evaluated and an opportunity for the public to provide feedback. The public meeting will be conducted both online and by phone.

This study will evaluate and assess the benefits and impacts for a range of feasible alternatives, including a no-build (do nothing) alternative. It also will identify mitigation necessary to offset potential impacts. Comments received during the public comment period will be used to help identify a recommended build alternative for the I-10 corridor and to complete the environmental assessment and design concept report documents.
