- Login and facilitated chat with ADOT Representative Greg Wristen, ECS Rebekah Morris provided the introduction and facilitated the chat.
 - Greg spoke about his background with ADOT.
 - ECS is updating its "Consultant Contract Manual". The manual discusses "how to do business" with ADOT ECS Department.

- 2. Meeting called to order & Welcome by DBE Task Force Chair Ignacio Malave called the meeting to order at 1:45pm.
 - ADOT Leadership Update Dallas Hammit provided the report
 - SEO Staff Changes
 - Two new Assistant District Engineers have come on board (Carl Ericksen, Northeast District and James Hartman, Central District)
 - Matthew Moul is the new Deputy State Engineer for Statewide Operations. Matthew replaced Jesse Gutierrez.
 - Presentation on ADOT's updated 5-year plan and funding Dallas Hammit presented.
 - 2021-2025 5-year Program (\$5 Billion)
 - Discussed ADOT upcoming projects including 2 Design contracts.
 - An overview was given on the breakout of funding per type of projects.
 - Discussed the I-10 Broadway Curve project and the major improvements this project will bring. Project was awarded in January 2021.
 - Discussed the I-17 Flex Lanes (Anthem Way to Sunset Point) project and the major improvements this project will bring.
 Expected contract approval in Fall 2021.

 - Public Meetings will be held in March, April and May. ADOT plans to adopt in June 2021.
- 3. Presentation: Preferred Developer of the I-10 Broadway Curve Pulice/FNF/Flatiron Anthony Devito presented for the PFF JV
 - Presentation provided an overview of the project.
 - Anthony provided background information on the JV Partners (Pulice, FNF, Flation)
 - Discussed the Org chart on the project
 - Discussed previous DBE Commitments that the partners have accomplished.
 - Provided the PFF Website: www.pulice-fnf-flatironjv.com to fill out pregual forms.
 - Gave an overview of opportunities available and the procurement process.
 - Anthony gave an overview of the ADOT website where DBEs can find "current advertisements".
- 4. Addressing barriers DBE Task Force led discussion Patti Olds facilitated subcommittee questions to Dallas Hammit.
 - Professional Services Subcommittee How is ADOT handling the rapid price increases of construction materials?
 - ADOT is consistently looking at cost increases on a regular basis and updating its data. Per Dallas Hammit, construction costs are roughly 8% under budget YTD, mainly tracking back to two individual projects: SR 24 and L303 bid prices coming in lower than expected.
 - Construction Subcommittee How is ADOT making training available for inspection of construction materials – concrete and asphalt?
 - Dallas is looking into and will provide further information regarding training.
 He explained ADOT is a board member of the association ACTI and allowed
 use of certain ADOT training spaces, but due to COVID those trainings were
 put on hold.

 - Tina provided an explanation on Race Conscious versus Race Neutral DBE participation.
 - Provided an explanation of the differences between Race Conscious and Race Neutral goals.
 - Discussed how the DBE goals were assessed and how the goals are brought out by Race Conscious and Race Neutral DBE percentages.
 - FY 21-23 DBE Annual Goal (RC 8.17%, RN 4.72% = 12.89%)
 - Discussed the research study recommendations to help DBE and Industry work towards being a Race Neutral State.
