




Project Tracking Report, also referred to as the Project Tracking Database Report.

The project tracking report displays scheduling data from Workfront combined with project planning data and accounting data to give a quick glance at design project status.




There are several ways to get to the Project Tracking Report.




One way is to click on the link in PIRT that will take you straight to it.










Both links will take you to the report where you can select projects using Fiscal Year ranges and include all projects within a specific time frame or you can filter the information to a specific quarter, district, Project Manager, etc.


By Default it is set to report ALL projects of ALL types in ALL districts in the current Fiscal Year.






The first step is to select the beginning Fiscal Year from the drop down menu











The next step is to choose the ending Fiscal Year for the report










Then select the quarter of the Fiscal Year to display. You can narrow the results down to just the quarter you want or you can select all quarters.








FY QTR 2 October - December FY QTR 3 January – March FY QTR 4 April – June

FY QTR 1 July – September


Fiscal Years start in July and go through June of the next calendar year.






Next you can select a specific district to show or use "ALL Districts" to see projects all over the state.










Then choose to see all projects, only advertised projects or projects that have yet to advertise.


Choose a COG or MPO.

- Defaults to ALL COG and MPOs.
- Similar to choosing a district by choosing a Counsel of Government (COG) or Metropolitan Planning Organization (MPO) you can filter the report to a geographic region represented by the COG/MPO











Choose to see projects for just one Project Manager. It is suggested that if you want to see all the projects managed by one person you change the rest of the filters to ALL.

All the other filters still apply so it is possible to choose filters where the project manager doesn't have any projects.










When you have the criteria selected you want then you select the "View Report" button.


Any time you change the filters you need to click on the "View Report" button.





Project Tracking Report loads as a big wide spreadsheet Export to a format to edit it





Export Button

- Reports can be exported into several formats.
- Click on the arrow to the right of the Disk icon to pull down a menu of export choices.
- ADOBE PDF locks the information.
- EXCEL Page Header export the data to a spreadsheet putting the Report Header into the EXCEL header section.
- The EXCEL only export format puts the report header in the first row.

The Project Tracking Report shows the basic project information like Route, County, Milepost, District, COG/MPO, TRACS, Project Name and Type of Work. It also shows who is the PM, the Scheduler, in-house or Consultant design and programmed funding amounts.

All of this information comes from AFIS, the Project Master and updated at PRB.

The Last PRB date is always an Actual date, all the rest are estimated dates unless there is an A after the date. The Environmental Clearance actually happened on 12/16/2016.
