



Parents/legal guardians can administer an eligible teenager's Driver Knowledge Test from the convenience of their home.

To qualify as a test administrator a parent/legal guardian must:

- ✓ possess a State-issued driver license or ID card.
- certify you are the examinee's parent/guardian.
- commit to administering the exam in a room or facility where access can be limited.
- ensure examinees do not have access to other mobile or electronic devices, documents, notes or writing materials during the exam.
- ✓ After passing the test, the teen must get the instruction permit at an MVD or Authorized Third Party office.



Steps





2. Verify your identity.



3. Select Test From Home.



4. **Complete** your teen's information.



5. **Submit** payment for the \$7 application fee.



6. **Proctor/supervise** your teen during the test.



7. After passing the test, get the instruction permit.



Once the test is complete, the teen should follow the steps for making an appointment on AZ MVD Now to get the instruction permit.

FAQ

Is there a time limit to complete the test?

A | The examinee has 30 minutes from the time the test is started.

When will we know the results of the test?

A | The test is scored as it progresses, so you will know the results immediately with an on-screen notification. A score of 80 percent or higher is required to pass.

What happens when a test is failed?

A | Additional attempts can be made. No additional fee is required.

What happens if the internet connection is lost during the test?

A | If the connection is lost, try again. It will not count as an attempt.

Once they've passed the test, what are the next steps for my teenager to receive their instruction permit?

Make an appointment at MVD to complete the instruction permit process. To do this, log out of the parent/legal guardian's AZ MVD Now account and the teen will activate their own AZ MVD Now account, which they will use to schedule the appointment.

If my teenager completes and fails their first attempt at an on-site location can they take additional attempts at home?

A | Yes, they can take additional attempts at home as long as it is administered by a parent/legal guardian.

Sample Questions

When you see or hear an emergency vehicle approaching:

- Immediately drive to the right side of the road and stop
- Slow down and permit the emergency vehicle to pass
- Remain alert and stay to the right

A flashing red traffic light at an intersection means the:

- Same as a Stop sign
- Light is about to turn green
- Same as a Stop light

If you are parking uphill and there is no curb, you should:

- Turn your wheels to the right, toward the edge of the road
- Turn your wheels to the left, away from the edge of the road
- Keep your wheels straight ahead
