- b. What are the **current strategies of ADOT & DBE Supportive Services** to increase utilization of certified DBE firms?
 - i. ADOT reviewed programs and policies available to DBE firms.
- c. **Constraints of ADOT** some of the issues DBE's mentioned in the Focus Groups are not within ADOT's influence or ability to control. Help us understand some of the things ADOT cannot do.
 - i. **ADOT** reviewed the process for setting DBE goals on projects and why they do not dictate *how* goals are met by private firms.
 - ii. **Patane and Samartinean** discussed the difference between training individuals working on behalf of ADOT on projects and how it would not be appropriate for ADOT to certify individual employees of a private firm.
- d. What does ADOT see as the impact of the **Federal Transportation Fund** increase? How will that trickle down to DBE firms?
 - ADOT discussed that eventually funds will flow to projects, but it is still too early to see specific project impacts of this increased level of funding.
