

Revenue Report: Highway User Revenue Fund (HURF)

- GAS TAX Strong decline month (-3.0%), strong growth FY 2022 (7.3%)
- DIESEL TAX Moderate growth month (0.8%), moderate growth FY 2022 (3.8%)
- VLT Strong decline month (-9.2%), strong decline FY 2022 (-2.6%)
- REGISTRATION Strong growth month (14.4%), strong growth FY 2022 (7.6%)


